2. INTRODUCTION

- 2.1 Sschedule 4 of the Constitution identifies welfare services, population development and disaster management as functional areas of concurrent national and provincial legislative competence and these functional areas has been assigned to the National Department of Social Development.
- 2.2. Outcome 13 of the National Development Plan: An inclusive and responsive social protection system has also been assigned to the National Department of Social Development to be the lead and coordinating Department. In keeping with addressing the multi-dimensionality of poverty and inequality, in the South African context, social protection is an umbrella concept that brings together, amongst others:
 - 2.2.1 Measures to address capability poverty: support to early childhood development and investments in children; labour market activation policies and measures that foster productive inclusion of the under-and unemployed;
 - 2.2.2 Protective measures for nutritional and food security. It is becoming increasingly evident in a growing number of countries that income is central but often not enough to ensure access to adequate quantities of nutritious food and nutrients.
 - 2.2.3 Developmental social service interventions to address (i) economic and social exclusion and strengthen social cohesion; (ii) ensure that families and individuals are able to access services, entitlements, and potential economic and social opportunities; and (iii) developmental social services to reach out and provide care to the vulnerable such as those affected by HIV, women & children abuse, disabled etc.
- 2.3 The NDA is part of a broader Social Development Sector, which the National Department of Social Development leads and therefore has a critical role to play towards the attainment of Outcome 13 more especially in ensuring that developmental services are accessed by poor communities;
- 2.4 The NDA act has assigned a specific mandate to the NDA is to contribute towards the eradication of poverty and its causes by granting funds to civil society organisations for the purposes of:

- 2.4.1 carrying out projects or programmes aimed at meeting development needs of poor communities; and
- 2.4.2 strengthening the institutional capacity of civil society organisations involved in direct service provision to poor communities.
- 2.5 In the course of implementing its mandate, the NDA is often confronted with legal changes which requires specialised expect legal knowledge.

5.1 Clarification of scoring system for Technical Evaluation

Lead Attorney (Total mark = 25)

- Participating law firms must submit copies of court orders confirming the lead attorney's admittance as an attorney and proof of him practicing law for the past 8 years.
- Failure to submit such certification will result in a score of (0) for this section.

Legal Secretary (Total mark = 15 marks)

- The law firm must submit a copy of their legal secretary's qualifications as evidence of him/her being qualified as a legal secretary together with evidence of proof of 5 years working experience.
- · Failure to submit such evidence will result in a score of (0) for this section.

Proof of Admittance as an Attorney (Court Order) (Total mark = 25)

- Participating law firms must submit copies of court orders confirming their team's admittance as attorneys.
- Failure to submit such certification will result in a score of (0) for this section.

References (Total mark = 20)

- References must be in writing, on the referee's letterhead, with the contactable details of the
 referee and must be signed by a duly authorized person. Any references provided in a different
 format will NOT be accepted and will be disqualified.
- The reference must provide; nature of project/work done, duration of project, project value and must confirm if the project was completed successfully. A copy of a Purchase Order will not be accepted as a reference.
- Should a service provider fail to submit the minimum number of the required references, they will score a (0) on this section.
- A full mark of (20) will only be obtained if the references provided meet all the requirements stipulated above.

6. MANDATORY COMMERCIAL DOCUMENTS

- 1) Price offer
- Valid Tax Clearance Certificate issued by the South African Revenue Services (SARS).
- 3) Letter of Authority authorizing the signatory to approve the submitted bid.
- 4) A copy of CSD registration confirmation.
- 5) Company registration documents (CIPC).
- Certified Sworn Affidavits or BEE verification certificate (Issued by an approved verification agency).
- 7) Completed and signed SBD documents.
- 8) ID copies of partners/owners.
- 9) Current Banking Details, Cancelled Cheque or Original letter from the Bank issued on a bank letterhead with stamp.
- 10) Fidelity Fund Certificate.
- 11) Registration with the Law Society- proof of the registration from the relevant law society must be provided.
- 12) Proof of right of appearance in the high court (for litigation)

Failure to submit the above requirements with the bid document will lead to disqualification. There will be no disqualification for none submission of a BEE certificate/sworn affidavit but service providers who do not submit will be scored a zero.

7. COMMERCIAL EVALUATION

- 7.1 Bids will be evaluated in accordance with the new Preferential Procurement Regulations, 2011. For the purpose of this bid, the 80/20 preference points system as prescribed in the Preferential Procurement Policy Framework Act (PPPFA, Act 5 of 2000) will be used. The lowest acceptable bid will score 80 (whichever will be applicable) points for price and maximum of 20 points (whichever will be applicable) will be awarded for attaining the Broad-Based Economic Empowerment (B-BBEE) status level of contribution.
- 7.2 The bid proposals received will be evaluated in two (2) phases. On the first phase bids will be evaluated on functionality and on the second phase in accordance with the 90/10 preference points system respectively.
- 7.3 Bid proposal must score a minimum of eighty (80) points or more out of hundred (100) points on functionality in order to qualify for advancement to the next phase of evaluation. Second phase, a bid proposal scoring less than 80 out of 100 will not be considered for further evaluation and will be disqualified.
- 7.4 Phase two: During this phase, bid proposals that passed the first phase will be further evaluated based on the 80/20 preference points system in accordance with the PPPFA Act, where 80 points will be attained in respect of price (the lowest acceptable bid will score 80 points and bidders that quoted higher prices will score lower points for price on a pro-rata basis) and 20 points will be awarded for attaining the Broad-Based Economic Empowerment (B-BBEE) status level of contribution in accordance with the table below:

7.5 In order to claim the B-BBEE Status Level of Contributor, bidders must submit Sworn Affidavits or original and valid B-BBEE Status Level Verification Certificate or certified copies thereof, issued by accredited Verification Agencies by SANAS or Registered Auditor approved by Independent Regulatory Board of Auditor (IRBA)together with their bids, to substantiate their B-BBEE claims. The Exempted Micro Enterprise must submit a letter from the Accounting Premises who is appointed in terms of Close Corporation Act.

- 7.6 Bidders who do not submit B-BBEE Status Level Verification Certificate or are noncompliant contributors to be B-BBEE do not qualify for preference points for B-BBEE but will not be disqualified from the bidding process. They will score points out of 80 for price only and zero (0) points out of 20 for B-BBEE.
- 7.7 Bidders are requested to complete the preference claim form in order to claim preference points.
- 7.8 The highest ranked bidder will be awarded the bid. It should be noted also that the NDA reserves the right not to appoint any service provider.
- 7.9 Bidders participating as joint ventures must submit BEE certificates reflecting the BEE rating of the joint venture. Individual BEE certificate for JVs will score a zero (0) for the BEE portion of the evaluation.
- 7.10 A bidder will not be awarded the points claimed for B-BBEE status level of contribution if it is indicated in the bid documents that such a bidder intends subcontracting more that 25% of the contract value to any other enterprise that does not qualify for at least the same number of points that the bidder qualifies for, unless the intended subcontractor is an EME that has the capability and ability to execute the sub-contract.
- 7.11 A contractor is not allowed to sub-contract more than 25% of the contract value to another enterprise that does not have equal or higher B-BBEE status level, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.

8. OTHER CONDITIONS

- 8.1 NDA reserves the right not to accept the lowest bid or accept the whole or part of any tender in order to pursue our objectives or rotation, promotion of equitable opportunities or not to consider any bid submitted. Participating service providers will not be reimbursed for expenses incurred while participating.
- 8.2 NDA will return late submissions.

9 CONTRACTING

- 9.1 Upon the conclusion of the selection process, NDA will establish a panel from which service providers are going to be selected on a rotational basis as when the services are required.
- 9.2 The NDA will only contract services providers at a point when work is allocated to them.
- 9.3 No contract shall exist until a signed SLA between NDA and the successful service provider has been agreed to and signed.

10 DISCLAIMER

10.1 If a bidder finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in the bid or any other information provided by the NDA (other than minor clerical matters), the bidder must promptly notify NDA in writing of such discrepancy.

- ambiguity, error or inconsistency in order to afford the NDA an opportunity to consider what corrective action is necessary (if any).
- 10.2 Any actual discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by the NDA will, if possible, be corrected and provided to all bidders without attribution to the bidder who provided the written notice.
- 10.3 No representations made by or on behalf of NDA in relation to this bid will be binding on the NDA unless that representation is expressly incorporated into the contract ultimately entered into between NDA and the successful bidder.

11 ADDITIONS AND AMENDMENTS TO THE RFQ

- 11.1 The NDA reserves the right to change any information in, or to issue any addendum to this bid before the closing date and time. The NDA and its premises, employees and advisors will not be liable in connection with either the exercise of, or failure to exercise this right.
- 11.2 If the NDA exercises its right to change information in terms of clause 11.1 all amendments will be posted on the NDA website and participating bidders will have the responsibility to regularly monitor the NDA website to ensure access to such changes.
- 11.3 The NDA will immediately disqualify a bidder from the bidding process if the bidder fails to notify the NDA of the conflict as required.
